- 1. Always obey the safety, security, and house rules of the CTICC.

- 5. If protective equipment is required for the area, you are visiting or working in, please ensure you use it.

- 13. No goods or contractors are allowed in the glass lifts.
- 14. No use of foul language or horseplay permitted while on the premises.
- 15. Emergency Instructions:

If an emergency alarm goes off during your visit and an evacuation is ordered, please evacuate to the assembly point situated nearest to you as per the Emergency Evacuation Plan. If this assembly point is not accessible for any reason, you will be directed to the secondary assembly point. It is important that you report to the assembly point so that we know you have evacuated CTICC safely.
